- That any and all decisions of any tournament judge, director, or official will be final in all respects.
- That competitive bass fishing, including travel to and from tournament venue, can be and is dangerous. Therefore the undersigned agrees that they shall be solely responsible for their own acts and omission and does hereby fully and completely release and forever discharge Still Waters Bass Club, Pioneer Drive Baptist Church and any agent member, participant, official, tournament judge or any other related person (the "released parties") from any and all claims, actions, damages, liabilities, or debts, known or unknown, at law or in equity which the undersigned has or may have against any of the released parties which is in any way related to the undersigned's participation in any Still Waters related event. Further the undersigned agrees to indemnify and hold harmless any of the released parties from and against any claims, actions, damages or debts, including attorney fees, which may be brought against any of the released parties due to or arising out of any act or omission of the undersigned.
- That tournament officials reserve the right to refuse entry and to terminate participation of any person in Still Waters Bass Club Open Tournament or event for any reason.
- That the undersigned may be asked to submit to a polygraph examination and agree to accept the results of any such examination.
- That the undersigned certifies that the information provided in this form is true and correct to the best of our knowledge and belief.
